Mr. President,

Sir, I have been in regular consultation with top J6 attorneys since 2021. I remain at your avail regarding the persecutions of J6 Americans under the Biden administration, and I will be leading Congressional Oversight Committee investigations into J6 political persecutions and the entrapment/prosecution/imprisonment/conviction of American citizens who had dared to engage their First Amendment right to challenge the oppression of election integrity and the denial of entry for almost a full year into their own United States Capital by Madame Speaker Pelosi. It was a dark era for our beautiful Nation, but We the People have prevailed Mr. President.

Now, Sir, I am presenting to you my specific counsel regarding exactly how I think you may best respond on “hour one” of your Presidency as it relates to the full pardon of J6 victims of political persecution.

- Commute the sentences to time served for every J6 victim who has been adjudicated by the biased Biden administration.
- Dismiss all pending adjudications of J6 victims of political persecution.
- Dismiss all ongoing investigations into J6 victims of political persecution.
- Establish a Presidentially appointed Task Force at the Department of Justice to review all commutations and dismissals for the consideration of full Presidential pardon. I estimate that this review process of about 3000 cases would be completed week by week over the course of less than 10 months.

The Presidentially appointed DOJ Task Force would examine each case on an individual basis with the intent of carefully identifying every individual persecution and unrighteousness suffering of each J6 victim. This meticulous review will guarantee that your Presidential pardons, when signed, will withstand the scrutiny of legal scholars around the world and ensure your status as an unwavering champion for righteousness under our Constitution. The DOJ Task Force would also provide case-by-case guidance to the DOJ regarding necessary requirements to return all property seized from J6 victims.

Personally, I see no problem with a full pardon of all J6 victims of political persecution under Biden. However, I am obligated to share with you my calm assessment of precisely what I believe is fully righteous, and the quiet counsel I am sharing here Sir both delivers immediate justice to every J6 victim and takes into account the “totality of circumstance” of seeking righteousness within the parameters of our Constitution and the scrutiny of blind justice.
